This GLASSi the Spotlight falls on **Gareth Jones, Marketing & Technical Director** - Window Solutions at REHAU UK, who was elected Chairman of the GGF's new Systems House Group. The position as Chair also means a place on the GGF Board through the Home Improvement Executive. In this exclusive interview, Gareth discusses the Systems House Group and his role as a GGF Board Director.

**Congratulations on being the first Chairman of the GGF's Systems House Group. How important is it for the GGF to have a specialist group for systems houses within the membership?**

Thank you. I think when you look at the membership profile of the GGF, the majority would be installation companies, with only a few window manufacturers. The number of systems house Members has grown over recent years which is very encouraging. As a systems house we have potentially different requirements from our membership of the GGF albeit there is of course some alignment with the fabricators and installers. The Systems House Group partly addresses this where we can form a united voice to serve the best interests of the Group but also, and perhaps more importantly, with their relative size and status within the market we feel we can offer the GGF support in its activities to act in the best interests of the industry as a whole.

**What are the key issues concerning system houses at present?**

Our initial meeting raised some technical issues which have affected all systems houses to some degree and in discussing these we will be able to seek a resolution that will benefit us all. I think the main thing is the promotion of good practice and supporting the GGF by ensuring our supply chain operates best practice throughout. We have discussed standards and specifications, which of course in the light of the recent tragic events in London have even greater significance and relevance than ever.

**What are the main objectives the Group has set for the next 18-24 months?**

In short:

- To influence policy makers in respect of building regulations and planning.
- To develop window manufacturing standards and establish consistent means of policing compliance.
- To collaborate with other GGF groups on new products and initiatives.
- To support the GGF in the recruitment of window manufacturers as Members of the GGF.
- To support in the creation and delivery of training programmes.
- To build closer relationships with bodies such as the National House Building Council (NHBC) and Local Authority Building Control (LABC).

Our next meeting is on 3rd August and I hope we can agree a set of actions and timescales to meet these objectives.

**Which GGF benefits do your company use most?**

Undoubtedly it is the involvement we have on the various groups. It is important for us to have a voice in the industry but also to contribute to the activities of the GGF. Aside from myself in the Systems House Group, Home Improvement Executive and GGF Board, my colleague Irene Smith is on the Marketing Communications Committee, Mark Gajda on the Home Improvement Technical Group as well as various participants in the regional events including Declan Coulter who was recently elected Chair of GGF Ireland.

**How does it feel to have the responsibility of being a GGF Board member?**

I am really proud and excited to be on the GGF Board. It is a really critical time for the GGF with the arrival of new CEO, Phil Pluck, and a new era following a series of changes over the past two years. I feel the GGF is moving in the right direction with a clear strategy aimed at enhancing the support of Members. There is a lot of work to do and I am looking forward to playing a very active role in helping the GGF achieve its objectives.

# Tech *Talk*

**Steve Rice, GGF Director of Technical Affairs,** provides a technical update on the Building Regulations and GGF Technical publications.

## Building Regulations

### ENGLAND

There is no indication that the general review and resultant changes to the Building Regulations in England will take place as planned in 2018 as the GGF has not been made aware of any specific work having been started.

However, following the recent tragic fire at Grenfell Tower and Coroner’s inquest report following the Lakeland House fire in London (in 2009), it is likely that Part B of the Building Regulations and the associated Approved Documents (Vol 1 – Dwellinghouses and Vol 2 – Buildings other than Dwellinghouses) will come under immediate scrutiny and we may see some changes in the near future before the full investigation of the Grenfell Tower fire is completed.

The GGF has offered Government support and our technical expertise in carrying out any review of the current situation. The GGF in conjunction with Members has responded to a recent Fire Sector Federation (FSF) survey which asked for questions and concerns for Government’s Independent Grenfell Advisory Panel to consider.

The Independent Advisory Panel will review the facts and consider if urgent changes to fire regulation are required and also in due course, offer recommendations as to how the construction industry should move forward to ensure new building or renovations to existing buildings are future-proofed.

The GGF will continue to monitor for any work starting on Approved Documents within the Building Regulations to enable the Federation to develop a strategy to influence at the proposal stage rather than only react to a consultation.

### SCOTLAND

The Scottish Government re-issued its Building Standards Technical Handbooks (Domestic and non-Domestic) in July 2017, however the minor changes made do not affect windows, doors and other glass and glazing products.

### WALES

The Welsh Government has decided to introduce a new Approved Document (AD) Q, in relation to Unauthorised Access (Security). The final AD when published is expected to be similar to AD Q in England, using PAS 24 as the basis of demonstrating compliance. Once published, the GGF will review and highlight differences, if any, to the published version of AD Q in England.

### NORTHERN IRELAND

The Northern Irish 2012 Technical Booklets are still current and there are no proposed changes for the foreseeable future. The GGF aims to work with the Northern Ireland Government in 2017 to develop guidance for homeowners when replacing windows and doors.

### REPUBLIC OF IRELAND

The GGF is now actively working to develop this ‘region’ and following meetings with Eire Government, confirmed that there are no proposals to change Building Regulations in the near future.



# Growing *Political* Influence

The GGF Members Survey 2016 showed that the Federation's political activity was deemed important to almost one third of the GGF Membership. From the survey's results and the growing need for a more coordinated approach to the GGF's political work on areas such as housing, safety and security, and energy efficiency, a new Political Strategy Committee was formed in March 2017 to ensure the Federation channels its resource efficiently and effectively.

The Committee is made up of five GGF Members, three GGF senior staff and two political advisers from GK Strategy – the GGF's political advisory firm.

In the first six months of the year, the Committee has been busy responding to political consultations mainly on issues around energy efficiency.

Following emergency situations such as the Grenfell Fire as well as the Manchester and London terror attacks, the Political Strategy Committee decided the GGF's response to support the authorities should and could be swifter. The Committee agreed to set up the GGF Government Advisory Panel (GAP) in June 2017.

This GGF initiative will change the relationship the Federation currently has with various Government departments. It will aim to make GGF responses quicker, more rounded and balanced.

Phil Pluck, GGF Chief Executive and Chair of the Political Strategy Committee, explains: "After the tragic Grenfell Fire, several sectors in the glass and glazing industry were concerned and prepared

to offer advice, but the vehicle wasn't quite there and there could have been mixed messages from different sectors. Previously, we would have waited on each specialist technical group meeting to decide on a course of action – with 20 specialist groups this would take months. With the GAP we're cutting through the bureaucracy and dealing direct with the technical experts with specialist knowledge of each given sector. This will expedite the whole process and of course make the GGF more accessible and useful to Government ministers and officials."

The GAP remit is to get involved in any 'emergency situation' where glass and glazing is part of the incident. 'Emergency situation' may seem a generic term but for the GAP's purposes it covers terrorist attacks, fires, natural disasters and any other major or serious incidents that involve glass or glazing products or services.

With a remit purely to advise and support, the GAP will allow the Government to draw on the GGF's expert and independent resources completely free of charge.

Though GAP experts will be selected from each specialist group currently within the Federation's infrastructure, the GAP will be a fluid advisory group that can draw on the most relevant experts to a particular situation. Experts from each relevant group will have input into a clear and concerted communication to national/local Government and other relevant authorities.

## GGF Grenfell Government Advisory Panel

The first GAP has been set up to help with the Grenfell inquiry and to support Government with technical help and advice. The dialogue (electronically and face to face) has already started with all Group Members from the Fire Resistant Glazing Group to Emergency Glazing Group through to all groups under the Home Improvement Executive.

The first raft of experts' comments have been reviewed and the GGF has now issued a list of the relevant questions, concerns and statements as one unified voice to the Fire Sector Federation (FSF) Survey and in writing, direct to their offices.

GK Strategy is also working on a "stakeholder's map" to make it easier for the GAP to identify primary and secondary targets in the fields of politics and regulation.

Emma Petela, GK Strategy Director, commented: "We aim to help the GAP be as influential as possible. We will ensure GAP experts quickly engage with the key figures around any emergency situation. We will also, in conjunction with the experts, engage with other organisations in the wider

construction industry to ensure the GGF voice is heard in the broader discussions and solutions."

To make the Government and relevant parties aware of the GAP, the GGF has already made contact with key politicians, including Prime Minister Theresa May and Sadiq Khan, Mayor of London. The Federation will also be promoting the GAP on the GGF website and writing to all the heads of key Government departments informing of them of the Panel and also fully explaining its purpose and how they can use it to inform and support their decisions to prevent and contain emergency situations for the safety and security of all.

# Health & Safety Matters

**Phil Pinnington, GGF Director of Health and Safety, provides an update on Health and Safety matters.**

In the past few years we've seen the number of work related fatalities plateau. The most recent data has shown fatalities have dropped very slightly (144 to 137). This is good in one respect but does show there continues to be a huge challenge. Construction as a proportion of industry still records the highest number of deaths. Last year 30 people lost their lives on sites and not necessarily all large construction projects.

The GGF has been made aware of four avoidable deaths in the past 15 months. When the circumstances have been fully analysed, the same themes often arise. All the cases have involved lifting and handling of some description. Unloading a vehicle or moving glass to multiple locations on site were the most common, but sadly unsecured glass units have also contributed to fatalities.

It's always easy to pontificate after the event and clearly this is not only unhelpful but sometimes patronising. What has been lacking in many of these situations is a clear understanding of the risks associated with handling glass.

The glass and glazing industry has significantly increased the sizes of glass and insulating glass units over the last 20 years. The introduction of triple glazing and the demands of architectural glass have also become common in our industry. It appears that not everyone in the supply chain has appreciated the safety risks handling such sizes and weights brings.

The Health and Safety Executive (HSE), has for a number of years been focusing heavily on the supply chain. Most of this work has been as a result of road accidents with heavy goods vehicles whereby loads have shifted in transit or the vehicle is ill-equipped to carry the weight or size. Although the logistics side of the supply chain is important it is also clear that the supply and receiver can play an active part in reducing the risk of injury.

The GGF has recognised that we can play our part in improving standards but we're also aware that this can only be effective when in partnership, so we are leading

a cross sector working group committed to a Code of Practice that will specifically address the handling, storage and transport of large architectural glass.

This group draws on experienced operational and safety specialists from GGF Member companies, The Council for Aluminum in Buildings (CAB) and Build UK. Once published, we hope to have this Guide used as a minimum expectation for glass suppliers and for principle contractors to use when ordering and installing large glass units and curtain-wall.

Finally, the HSE is set to finally publish the long awaited report into "solvent based hydrophobic coatings and risks for acute respiratory toxicity". We've already had sight of the report and dissected some of the findings. The GGF will be issuing a press statement in the coming weeks, commenting on the report and providing a summary of its findings.
