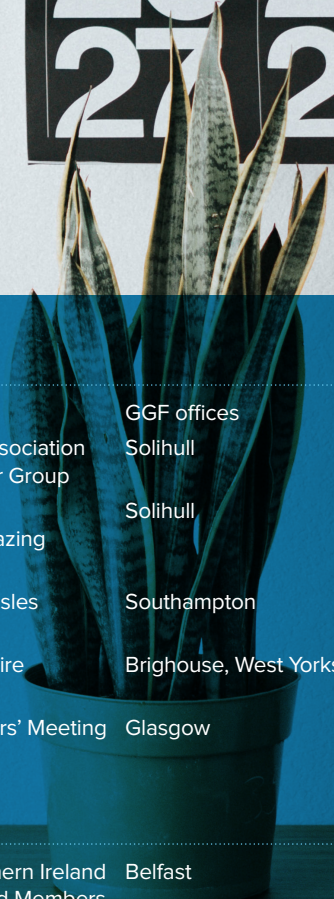

# Silver to Gold

## Spotlight on a Member, David Thornton

With more than 40 years' SME experience, David Thornton created the award-winning The Window Company (Contracts) Ltd in 2010.

He has been on the GGF Home Improvement Executive since 2016 and was elected Chair of this Executive Committee in 2017, when he was also elected onto the GGF Board. In 2018, his company became the first ever to attain Gold Level on the GGF's GLASS Charter Health and Safety Merit Scheme. In this interview, David discusses the journey and benefits of attaining GLASS Charter Gold.





### **HOW DOES IT FEEL TO BE THE FIRST COMPANY TO ACHIEVE GOLD STANDARD IN THE GGF'S GLASS CHARTER HEALTH AND SAFETY MERIT SCHEME?**

We're very proud to be able to say that we were the first company to achieve Gold – it's a tremendous achievement and a real accolade for the whole team. Gold is only awarded to those companies who can demonstrate that a health and safety culture is embedded right across the business and that the very highest standards are adhered to at every level. It definitely shows just how seriously we take our responsibility for our own workforce and to the homes and businesses that we work in.

### **WHAT CHALLENGES DID YOU FACE IN YOUR JOURNEY OF ACHIEVEMENT?**

We already held the GLASS Charter Silver Level 3 when we went for the Gold Level, so were already a long way down that journey. However, the biggest challenge we still had to overcome was to eliminate any risk to our fitters when climbing onto roofs of our vans to retrieve ladders. We did that by working with a specialist provider to adapt a new pneumatic lifting and lowering mechanism for our ladders which enables them to be raised or lowered using just a pole. It took us some time to develop the adaption kit and positioning, but it is proving really successful and could easily be rolled out to other installers around the UK.

### **HAS IT CHANGED THE WAY YOUR EMPLOYEES WORK?**

Aside from our new ladder mechanism, achieving Gold Level was all about identifying incremental improvements which together make a difference for our fitters. It prompted us to review every aspect of how we do things and to drill right down to make sure there were no areas we had overlooked. That has been a good exercise for all of us and not just for the management team responsible for health and safety.

### **HOW HAS IT WORKED FOR YOUR COMPANY AND CUSTOMERS?**

Health and safety is a key area of scrutiny for all our commercial customers so it's a real commercial advantage for us to be able to prove that we have met the very highest industry standards. It gives our customers absolute confidence in our processes and disciplines and of course, also sends out a really good message to existing and potential staff about how we put their wellbeing at the heart of what we do.

### **IN A NUTSHELL, HOW WOULD YOU SUM UP THE GGF'S GLASS CHARTER MERIT SCHEME?**

Because it's got the backing of the GGF, the scheme has got real credibility in the industry – it's easy to access and provides a really useful, structured path to success. We have never just paid "lip service" to health and safety, but even so, this scheme has involved people at all levels in the company and brought health and safety very much to the forefront of people's minds. We would certainly recommend it to others.

David's arrival overlapped with the retirement of Russell Day who left the GGF in June. Russell has been a stalwart for the GGF, joining the Federation nine years ago as a Technical Officer and going on to become our Director of Home Improvement for several years. On behalf of all connected to the GGF, I would like to thank Russell for his outstanding service and wish him all the best for the future.

Though the department is going through a transition, we are continuing to provide our services seamlessly to ensure Members are kept up-to-speed with all the technical issues and changes that are happening in the industry.

One area which we have been highly focused on is fire safety. Recently, the GGF had a strong presence at FIREX International which was a huge success. At this high-profile exhibition, the GGF had a large stand showing live exhibits of how fire resistant glass performs, highlighting the before and after effects of exposure to fire and smoke. In addition, Adrian Blaydon, GGF Technical Officer, conducted a presentation on "The Importance of Fire Resistant Glazing" to a packed audience who queued afterwards to receive a copy of the GGF's Fire Resistant Best Practice Guide.

Staying on events. In May, the GGF Laminators and Tougheners' Group, piloted a "Safety and Security Technical Forum" in Solihull which was well received by delegates from across the glass manufacturing and processing sectors.

## REVIEW OF BUILDING REGULATIONS

The final report from Dame Judith Hackett was published on 17th May 2018. It is a 156 page report with an 11 page executive summary from which the Construction Products Association held a complete review of the Building Regulations. The GGF attended the review meetings and since then the Government released a consultation entitled "Building a Safer Future". The GGF has responded to this consultation.

## TECHNICAL PUBLICATIONS

Currently, the Technical team is also working on the following technical documents including:

- 3.1 – Glass Sustainability Data Sheet.
- 4.2 – System Design & Glazing for Insulating Glass Units.  
A two-part Data Sheet; 4.2.1 will incorporate the current part 1 of 4.2 and will be revised once the final revisions of EN 1279 have been published. A new datasheet 4.2.2 will be created and will incorporate the current parts 2 & 3. These will be revised once BS 6262-5 has been written and published, likely to be late 2019.
- New series of Data Sheets – "Glass in the Home" is being created. This series will include, glass furniture, showers and baths, kitchen worktops, splashbacks and glass related white/brown household goods.
- All GGF Health and Safety Data Sheets are being completely revised.
- Revision of the GGF's 'A Guide to Best Practice in the Specification and Use of Fire-Resistant Glazed Systems'.
- Fire-resistant IGUs', a draft has been produced by the Fire Resistant Glazing Group and further to approval by The GGF Standards Committee, will be circulated for Members' comments in due course.
- Consumer guide for Conservatories is in progress and launch is expected in autumn 2019.

## The Impact of The Hackitt Report

Following the Grenfell Tower fire tragedy in 2017, Dame Judith Hackitt was commissioned to conduct an Independent Review of Building Regulations and Fire Safety.

From the review, in May 2018, Building a Safer Future, Independent Review of Building Regulations and Fire Safety: Final Report, was published, setting out more than 50 recommendations for government as to how to deliver a more robust regulatory system.

Peter Capelhorn, Chief Executive of the Construction Products Association, was asked by Dame Judith Hackitt to Chair the Regulations Working Group for the Review and has since led the Industry Response Group and discussions on the implementation of the recommendations made in the Hackitt Report.

At Members' Day, Peter will share his knowledge and concerns for the construction industry ahead of the changes in Building Regulations.

In addition to our keynote speakers, the GGF will also have presentations and updates from Steve Rice, GGF Managing Director, and Anda Gregory, Managing Director of the GGF's commercial companies including FENSA, BFRC, GGF*i*, RISA and Borough IT.

# The GGF GLASS Charter

## ASPIRE TO BE THE BEST YOU CAN BE

Health and Safety in our industry often expects companies to meet or exceed a set of minimum standards, whether it's in simple compliance with legislation, or in the case of an increasing number of construction projects, particular accreditations.

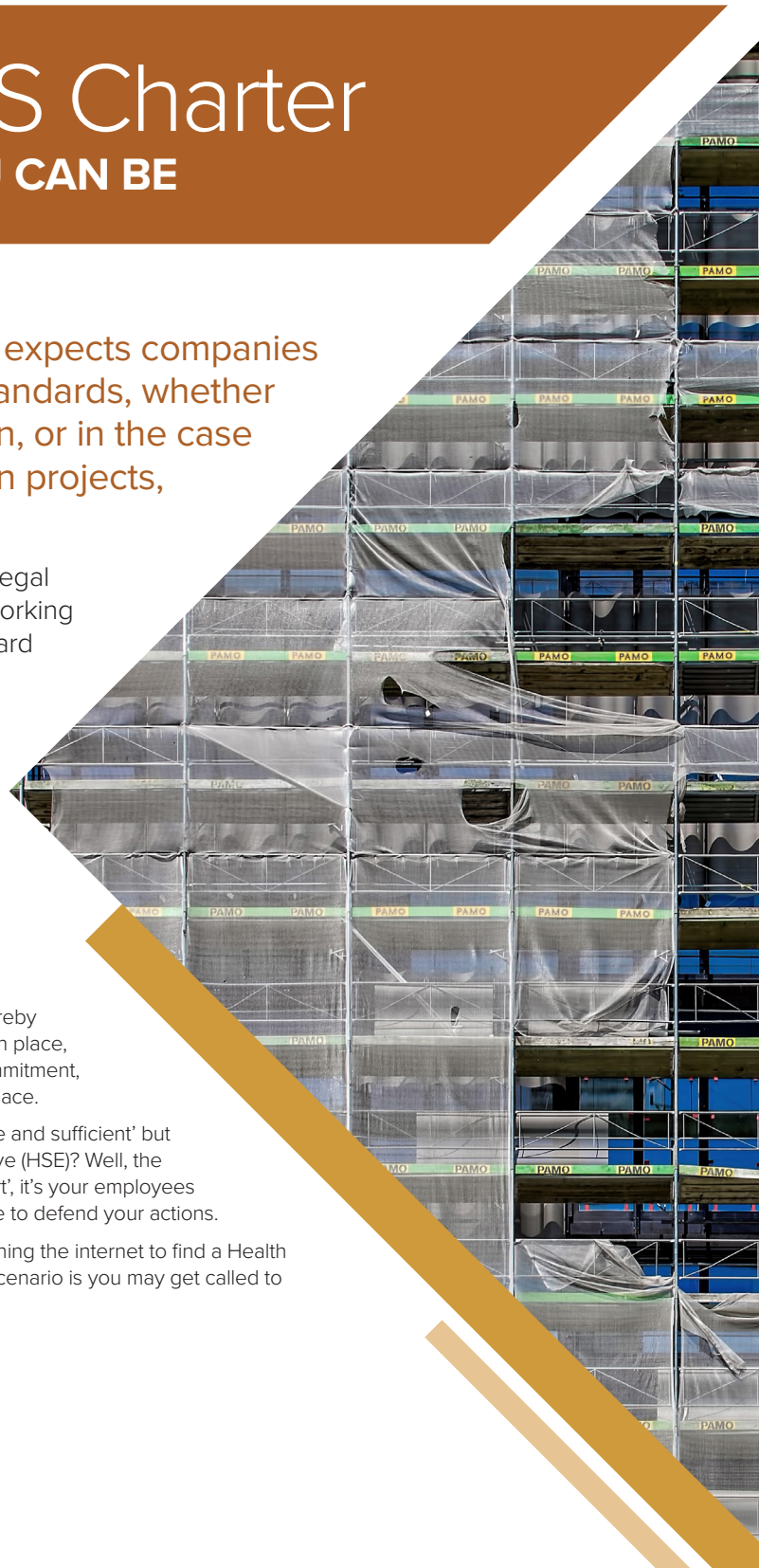
Before going any further, it has to be made clear that legal compliance is the minimum any business should be working to, but at the same time, it shouldn't be the only standard that a business maintains. Any business should strive to improve and become better. By striving for better Health and Safety standards, it's inevitable for companies to find improvement in staff retention and their quality of work.

Often when talking Health and Safety, one of the most common things that seems to hamper many business owners is the cost in time and manpower it takes to ensure good practice. It's not unusual to hear comments such as "This will take months" or "I'll have to employ someone to do this", and an old favourite, "I can't justify the cost of this".

These are often valid reasons, but if a company is in the position whereby winning that big contract relies on them having a good infrastructure in place, then rather than give reasons not to invest resource, thought and commitment, they should aim to ensure the right procedures and practices are in place.

Take the example of risk assessments. By law, they should be 'suitable and sufficient' but who decides, you or the client, or even the Health and Safety Executive (HSE)? Well, the simple answer is you, the company. It's your assessment as the 'expert', it's your employees doing the work, and inevitably if things go wrong, it's you that will have to defend your actions.

This may, on the face of it, seem very daunting and you may be searching the internet to find a Health and Safety consultant in your area, but hold fire. Yes, the worst case scenario is you may get called to account if things go wrong, but everything should be in perspective.



As a GGF member, you have a Health and Safety resource, somewhere you can go to get competent advice, guidance, a sense check or perspective. We deal with many processors, installers, and fabricators, and as a neutral body, we share good practices to help businesses overcome unfamiliar situations.
