Criteria for GGF Membership

To become a GGF Member, your company must:

• Have been trading in a glassrelated field for at least 3 years

If you have been trading for less than 3 years, you may apply to join the GGF Promotion Programme. For more information on joining the Promotion Programme either telephone 020 7939 9101 or email promotion@ggf.org.uk

- Be financially sound as evidenced by the company's accounts
- Have suitable business premises
- Have adequate personnel to conduct your business efficiently
- Be working to Standards that meet the Federation's technical and commercial requirements
- Provide three trade references to be taken up by the Federation

- Sign up to and comply with the GGF's Consumer Code of Good Practice and Customer Charter where the company deals with consumers
- Subscribe to the GGF's lowcost Deposit Indemnity Scheme to protect deposits where the company deals with consumers and takes deposits
- Sign up to the GGF GLASS Charter Health and Safety Initiative for the industry (see page 9 of this brochure) and its Merit Scheme
- Agree to display the GGF logo on the Company's website, stationery and other advertising material, with a link to the GGF website via the logo
- Agree that your Company's conduct will be monitored

Companies applying to join will need to pass the GGF's strict vetting procedure, which will include a site visit to the company's premises.

Applications from companies wishing to join are published in the GGF's fortnightly newsletter, GGF Newswire.
